WHEREAS, such updates are required to extend status to the City of Alpharetta as a Qualified Local Government,

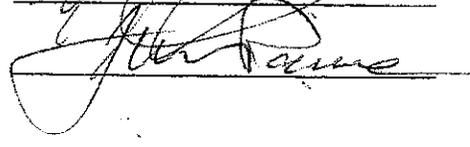

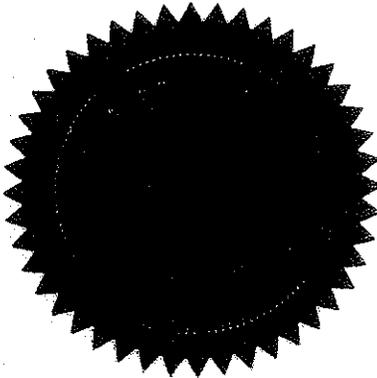
