A RESOLUTION OF THE RIVERDALE MAYOR & CITY COUNCIL, APPROVING THE SUBMISSION OF THE CITY OF RIVERDALE SHORT-TERM WORK PROGRAM OF THE COMPREHENSIVE PLANE FOR STATE AND REGIONAL REVIEW AND TO PROVIDE FOR AN EFFECTIVE DATE.

WHEREAS, The Mayor and Council, as the governing authority of the City of Riverdale, Georgia has participated in developing the required Short-Term Work Plan to the City of Riverdale Comprehensive Program; and

WHEREAS, The City of Riverdale is committed to promoting its vision of improving the communities that it serves by careful planning, community involvement and partnerships with local and regional governmental agencies; and

WHEREAS, The City of Riverdale has completed the Short-Term Work Program elements in accordance with the Rules and Procedures of the Georgia Department of Community Affairs.

NOW, THEREFORE, BE IT RESOLVED that this Resolution be and is hereby approves the submittal of the City's 2013-2017 Short-Term Work Program to the Atlanta Regional Commission (ARC) and the Georgia Department of Community Affairs for state and regional review and to provide for an effective date, shown below.

Section 1. Purpose. The purpose of this resolution is the Riverdale City Council offers approval to submit City of Riverdale Short Term Work Program.

Section 2. Filing Copies of the Final Agreement. The City Manager is authorized and directed to file a copy of said resolution in the Office of the City Clerk where it shall be certified and made available for public inspection. Certified copies shall also be filed in the Planning & Zoning Department.

Section 3. Severability. If any section, part, or provision of this resolution is held invalid, unenforceable, such invalidity or unenforceability shall not affect any other portion of this resolution, and all parts, sections, whereas clauses, and other provisions of this resolution shall be severable.

Section 4. Effective date. This resolution shall become effective immediately upon its adoption.
