INTERIM FINDING: ARC staff has completed the review of this application for a MRPA Certificate. The ARC staff Interim Finding is that the proposed land disturbing activity is inconsistent with the Chattahoochee Corridor Plan standards, with a recommendation to not build the proposed houses on the site and a further recommendation to either not develop the property or to develop a use consistent with the current zoning and the terms of the 1978 Chattahoochee River Park review. It is ARC's understanding that the City of Roswell is negotiating with the applicant, and this review process will remain on hold until there is a resolution.

This letter is a notification of receipt of the MRPA Review Notification RC-17-01R 201 Azalea Drive for the City of Roswell in Fulton County, Georgia. This project will involve the construction of two single family homes on lands previously included in the Chattahoochee River Park Phase II review (RC-78-87FC).

Congress established the Chattahoochee River National Recreation Area (CRNRA), a unit of the National Park Service (NPS), in 1978 for the preservation and protection of a 48-mile stretch of the Chattahoochee River from Buford Dam to Peachtree Creek. CRNRA consists of the river and its bed along with the lands, waters, and interests within the park's authorized boundary. Congress expressly provided the Secretary of the Interior, acting through the National Park Service (NPS) and CRNRA, with the authority to protect the "natural, scenic, recreation, historic and other values" of the Chattahoochee River.

The Georgia Metropolitan River Protection Act of 1973 (MRPA) protects the river corridor from inappropriate land use and includes language that provides for protection of aesthetics and viewsheds in the vicinity of the park. The Atlanta Regional Commission's preliminary findings found the proposed land disturbing activity to be inconsistent with the Chattahoochee Corridor Plan standards. The CRNRA concurs with these findings and requests that this application be denied.
