

Groundbreaking ceremony for this 1.75 mile leg of the trail was held on March 4, 2017. Also, a scoping study was completed for the extension of the Noonday Creek Trail into Cobb County, and a TIP funding application has been submitted for construction funds.

The 2017 free Summer Concert Series has been well-attended, and several other events have been held at the now very popular Northside Hospital Cherokee Amphitheater. The most recent concert, Drivin' and Cryin', drew an estimated 12,000 people. Cost of the project was estimated at \$2.5 million, actual cost was \$3.25 million.
