Chief,

Attached is a 'to-date' budget report on the Impact Fee Fund. Please note that we had originally placed \$41,750 within the PD Impact Fee Fund to pay for firearms. Of which, only \$2,150 is remaining.

This means that we would need to take a budget amendment to Council for their approval. However, from Mr. Patton's and Mr. Ross' comments, we will have to add these to the CIE prior to making the purchase; which I believe takes a certain amount of time???

I will be more than happy to prepare a budget amendment whenever Mr. Peppers gives me the go ahead. I might add though, if it is going to take a few months (or longer) to get this project onto the CIE, we may want to simply include it in the upcoming FY '18 Budget.

Alternative Consideration: Can we purchase out of the General Fund and then reimburse from Impact Fees once it is approved? ...or at least purchase the initial 'test' unit out of the General Fund with the anticipation of purchasing any additional units out of the IFF once it is added to the CIE?
