# RESOLUTION OF SUBMITTAL LAND USE PLAN AMENDMENT

WHEREAS, the City of Sugar Hill, Georgia, has completed an Amendment to the Comprehensive Plan of 1998, said plan being more fully entitled the *City of Sugar Hill Comprehensive Plan*; and

WHEREAS, this Land Use Plan Amendment relates to the incorporated limits of the City of Sugar Hill and primarily affects the Land Use Element of the Comprehensive Plan, including the Future Land Use Plan map; and

WHEREAS, this Amendment was prepared in accordance with the Minimum Planning Standards and Procedures for Local Comprehensive Planning established by the Georgia Planning Act of 1989, and duly noticed Public Hearings were held on October 28, 2004, November 18, 2004, January 18, 2005 and February 14, 2005 by the City Council at 7:00 p.m. at the Sugar Hill Community Center in Sugar Hill, Georgia;

BE IT THEREFORE RESOLVED, that the Mayor and City Council of the City of Sugar Hill, Georgia, hereby submits the Land Use Plan Amendment to the Atlanta Regional Commission for Regional Review, as per the requirements of the Georgia Planning Act of 1989.
