adopting a recreation impact fee; and

WHEREAS, the City of Acworth held a public meeting at City Hall on May 24, 2005 before

the Planning Commission and a public hearing on June 2, 2005 before the Mayor and Board of Aldermen on the proposed annual Update to the Comprehensive

Plan; and

WHEREAS, the Mayor and Board of Aldermen adopt the attached Draft Short Term Work

Program Update and CIE to the City of Acworth Comprehensive Plan; and

WHEREAS, Submits all necessary documents to the State Department of Community Affairs

and the Atlanta Regional Commission in order to meet the minimum requirements

of the Annual Update to the City of Acworth Comprehensive Plan.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN that the draft update to the Short Term Work Program and CIE as outlined in the attached be hereby adopted along with all applicable statutes and regulations relative thereto and submitted to the State Department of Community Affairs and the Atlanta Regional Commission. Once approved, by the ARC and DCA, the Mayor and Board shall adopt the update.
