RESOLUTION TO APPROVE SUBMISSION OF THE COMMUNITY ASSESSMENT AND COMMUNITY PARTICIPATON PLAN COMPONENTS OF THE

2005 - 2025 CITY OF STONE MOUNTAIN COMPREHENSIVE PLAN UPDATE TO THE ATLANTA REGIONAL COMMISSION FOR REVIEW

WHEREAS, the City of Stone Mountain, Georgia is required, pursuant to Georgia law, to develop and maintain a Comprehensive Plan; and

WHEREAS, the Stone Mountain Comprehensive Plan was adopted in 1995 pursuant to the coordinated planning process as set forth in the Georgia Planning Act of 1989 and was prepared to meet the State Planning and Procedures; and

WHEREAS, the Stone Mountain Comprehensive Plan establishes a framework that is the basis for local government decision making regarding community facilities, housing, economic development, natural and historic resources, and future patterns of land use; and

WHEREAS, the City of Stone Mountain is currently engaged in a planning process to prepare an update to the 1995 Stone Mountain Comprehensive Plan; and

WHEREAS, the update to the 1995 Stone Mountain Comprehensive Plan is being prepared in accordance with the Standards and Procedures for Local Comprehensive Planning as effective May 1, 2005; and

WHEREAS, the first phase of that planning process has been completed and the city is preparing to begin work on the COMMUNITY AGENDA component of the Comprehensive Plan; and

WHEREAS, the City of Stone Mountain certifies that the public review and hearing requirements were met during this phase of the planning process.

NOW THEREFORE BE IT RESOLVED, by the City of Stone Mountain to transmit the Community Assessment and Community Participation Plan components of the 2005 - 2025 Comprehensive Plan for the City of Stone Mountain to the Atlanta Regional Center for review.
