**A RESOLUTION
BY THE BOARD OF COMMISSIONERS OF FULTON COUNTY
TO TRANSMITT THE DRAFT FULTON COUNTY SOLID WASTE
MANAGEMENT PLAN TO THE ATLANTA REGIONAL COMMISSION AND THE
GEORGIA DEPARTMENT OF COMMUNITY AFFAIRS FOR REVIEW**

WHEREAS, the Board of Commissioners is required by the 1989 Georgia Planning Act to develop a Solid Waste Management Plan which meets the minimum standards for local comprehensive planning established by the Act, and

WHEREAS, the Department of Community Affairs requires Fulton County to adopt a Solid Waste Management Plan, and

WHEREAS, it is necessary to periodically update the Solid Waste Management Plan for Fulton County to ensure adequate collection, transportation, and disposal of solid waste, and

WHEREAS, the Solid Waste Management Plan has been prepared by the Fulton County Public Works Department, and

WHEREAS, the Fulton County Department of Public Works has afforded a full review, including official public hearings, of the Solid Waste Management Plan, and has approved the Plan for transmittal to the Board of Commissioners with a recommendation for adoption; and

WHEREAS, the extension of the Qualified Local Government status is contingent upon official adoption by the Board of Commissioners of the Solid Waste Management Plan;

WHEREAS, after review of the Solid Waste Management Plan by the Atlanta Regional Commission and the Department of Community Affairs, the Board of Commissioners will consider the plan for adoption.

NOW THEREFORE, BE IT RESOLVED, that the Solid Waste Management Plan be approved for transmittal to the Atlanta Regional Commission and the Georgia Department of Community Affairs for their review and action.
