

**WHEREAS,** the Annual Update of the Capital Improvement Element and Short Term Work Program was prepared in accordance with the Development Impact Fee Compliance Requirements and the Minimum Planning Standards and Procedures for Local Comprehensive Planning established by the Georgia Planning Act of 1989. A public hearing was advertised and held at the Chambers at City Center on May 20, 2024, at 7 pm.

**NOW, THEREFORE BE IT RESOLVED,** that the Mayor and Council of the City of Woodstock, Georgia does hereby adopt the annual update of the Capital Improvements Element and the Short-Term Work Program, covering the five-year period of 2023-2027.


