## 13. Description of Project (Describe exactly what the grant funds will pay for and what work will be completed as part of this project, limited to space provided):

The Scope of Work includes the design and construction of approximately 2600 ft. of new trail and amenities and improvements to 1600ft of existing trail. The grant funds are being requested to pay for engineering, material and labor costs. The design and engineering costs required to create construction documents may include, but not be limited to, a Topographic Survey, a Site Plan, Erosion and Sediment Control Plans, a Site Details Plan, a Landscape Plan, Construction Details and Specifications, and Construction Administration. #### **Project Narrative**

### Kennesaw Community Trails Phase II

The Kennesaw Community Trail Phase II project is a continuation of the Phase I trail implementation. These two phases of the Kennesaw Community Trail System are in response to recommendations presented in the <u>2003 Livable Centers Initiative study</u> and the <u>2004 Kennesaw Parks, Recreation and</u> <u>Open Space Master Plan Update</u>. The recommendations call for constructing a trail system from Adam's Park, located just south of downtown Kennesaw, to Jiles Road near the Legacy Park Community. This trail would provide a valuable link to downtown Kennesaw for residents located in the northern most communities of the City. Upon completion of phase III, the trail is expected to immediately link four neighborhood communities through which the trail passes to downtown. An additional four neighborhood communities will have access to the trail system via a short walk using sidewalks.

The initial trail loop spans approximately 2,300 feet through Deerfield Park located to the south of Deerfield Drive. The Phase II trail will begin at Deerfield Park, north of Deerfield Drive, and follow Proctor Creek through the Deerfield and Winchester Forest subdivisions. The trail will continue through the Winchester Forest subdivision following the creek to the western edge of the Bridges of Kennesaw Apartment Community before finally reaching Jiles Road.

The total length of the Phase II trail will be approximately 4,200 feet. The trail route presents numerous opportunities to experience abundant wildlife such as deer, squirrels, insects, and birds as well as to see unique geographic features and specimen American Beech, Oak and Hickory trees that are scattered throughout the trail route.

Preliminary observations suggest that several new bridges will be required for stream crossings. An opportunity exists to re-deck and re-use an old bridge on the Bridges of Kennesaw property in order to access Jiles Road. Also, the use of a boardwalk may be required to traverse the creek in the Winchester Forest subdivision at Winchester Park. The boardwalk may present a unique opportunity for users to observe the ecology of Proctor Creek from an advantageous height.

#### Section III – Environmental Survey

#### 1. Land Use:

The trail will be constructed on city-owned property with the exception of the land parcel adjacent to Jiles Road and owned by Kennesaw Residential Associates LLC. This parcel does contain a Cobb County Sanitary Sewer Easement on which an existing trail is located. It is presumed that the trail was constructed by the Kennesaw Residential Associates LLC for use by the residents of the apartment community. With the exception of the apartment community, the surrounding land use is established, single-family residential. Two local parks, Deerfield Park and Manchester Forest Park, are located along the proposed trail route. No land use changes are expected due to the construction of the trail.

The Kennesaw Community Trails Phase II project is a continuation of the Phase I trail construction. The Kennesaw Community Trail System is being implemented in response to recommendations presented in the <u>2003 Livable Centers Initiative study</u> and the <u>2004 Kennesaw Parks. Recreation and Open Space</u> <u>Master Plan Update</u>. The recommendations call for constructing a trail system from Adam's Park, located just south of downtown Kennesaw to Jiles Road near the Legacy Park Community. This trail would provide a valuable link to downtown Kennesaw for residents located in the northern most sections of the City.

Two maps are attached to illustrate the location of the trail, its relationship to the adjacent properties and surrounding land use.
