The Atlanta Regional Commission (ARC) has received the following proposal and is initiating a regional review to seek comments from potentially impacted jurisdictions and agencies. The ARC requests your comments related to the proposal not addressed by the Commission's regional plans and policies.

Description: To impact 1335 linear feet of streams to construct road improvement. STP-9252(6) is the proposed widening and improvements of approximately 1.24 miles of Johnson Ferry Rd in Cobb and Fulton Counties from Collumns Drive to Abernathy Rd including the widening of the bridge spanning the Chattahoochee River. The proposed improvements to Johnson Ferry Rd would widen the existing four lane roadway from Columns Drive to Riverside Dr to six lanes including a 16-foot raised grass median, 4-foot bike lanes, 16-foot urban shoulders and 8-foot sidewalks. Johnson Ferry would then maintain the four 11 foot traver lanes from Riverside Dr to Abernathy Rd and introduce a 16-foot raised grassed median, 4-foot bike lanes, 16-foot urban shoulders, and 8 foot sidewalks. STP 9250(1) is the proposed widening and improvements of approximently .93 miles along Abernathy Rd from Johnson Ferry Rd to Roswell Rd. The improvements to Abernathy Rd would widen the existing two 12-foot lane lane roadway to four 11-foot lanes with a variable 16 to 32-foot raised grassed median, 4 foot bike lanes, 16 foot urban shoulders, and 8-foot sidewalks.
