### RESOLUTION BY THE ATLANTA REGIONAL COMMISSION CONCERNING THE SMITH LANDFILL DEVELOPMENT OF REGIONAL IMPACT

WHEREAS, on May 16, 1996, the Atlanta Regional Commission received from Gwinnett County a request to review a proposed 1.5 acre inert landfill to be located on Suwanee Dam Road and called the Smith Landfill; and

WHEREAS, any proposed new waste disposal facility is subject to review as a Development of Regional Impact (DRI); and

WHEREAS, the proposed site is contiguous to the City of Sugar Hill and therefore has intergovernmental impacts; and

WHEREAS, the proposed landfill is in an area shown on both the Gwinnett County and Sugar Hill Comprehensive Plan land use maps as residential; and

WHEREAS, the surrounding uses in the City of Sugar Hill and Gwinnett County are residential development and the City of Sugar Hill Golf Course; and

WHEREAS, the proposed landfill is incompatible with existing and proposed land uses as reported by Gwinnett County and Sugar Hill; and

WHEREAS, the staff has received comments of concern about the DRI from the City of Sugar Hill;

NOW, THEREFORE, be it resolved that the Atlanta Regional Commission finds the proposed use is not in the best interest of the State.

Dear Ms. Rhea:

I am writing on behalf of the City of Sugar Hill in response to your letter of May 16, 1996 requesting comments on the above-referenced development of regional impact. The property proposed for the inert landfill is located immediately adjacent to property lying within the corporate boundaries of the City of Sugar Hill, and the City of Sugar Hill believes that the project would not be in the best interest of the City of Sugar Hill or the State of Georgia.

Although a review of the Sugar Hill City Zoning maps would indicate that property immediately across Suwanee Dam Road from the property is zoned HM2 (Heavy Manufacturing), this zoning designation is somewhat misleading. The property contains this designation because it houses a wastewater treatment facility. This facility was originally constructed by the City of Sugar Hill and was sold to Gwinnett County in December 1995. The wastewater treatment facility is not visible from the public roadway and does not detract from the area. The wastewater treatment facility is a spray irrigation facility and the effluent is sprayed on an 18 hole public golf course which is located immediately adjacent to the wastewater treatment facility on the large tract of land located across the road from the proposed inert land fill. The public golf course is owned and operated by the City of Sugar Hill and has been quite successful. The City has recently completed construction of a new clubhouse facility at the golf course.

As a result of the location of the public golf course, and the availability of sewer in this area, several property owners have annexed property in the immediate area into the City of Sugar Hill and have developed the property for residential use. One such development is the Links Subdivision which is located immediately adjacent to the proposed inert landfill. In addition, several other large residential projects are proposed for the general area. The property immediately adjacent to the Sugar Hill golf course is owned by the United States government and is park land which reaches from Suwanee Dam Road to the Chatahoochee River. There are a number of large residential tracts in the area including a horse farm located along Suwanee Dam Road less than a mile east of the proposed inert landfill.

Also, the City believes that this project would generate more than 15 truck loads of debris per week. This number is too conservative.

For the reasons set forth above, the City of Sugar Hill believes that development of an inert landfill in the proposed location would be inconsistent with existing land uses in the immediate area, could have a detrimental impact on existing and proposed residential development within the City of Sugar Hill and could negatively impact on the operation of the Sugar Hill public golf course which is located on the opposite side of Suwanee Dam Road from the proposed landfill. The City encourages the Atlanta Regional Commission to recommend that development of an inert landfill at this location is not in the best interest of the state.

It is unconscionable with the gravity of this situation and the financial implications to The Links Subdivision and the legal ramifications to Mr. Smith, et. al., created by the illegal dumping on his property, now known by the Environmental Protection Division, Gwinnett County, and the Atlanta Regional Commission, that Mr. Smith would make a joke and mockery of our notification to him in our attempt to amicably resolve this matter without having to seek legal counsel.

In consonance with your instructions we are providing copies of our previous documentation as notification to those authorities which would have an affect upon the outcome of this unconscionable SPECIAL USE PERMIT request which is tantamount to a spot zoning for commercial usage as per Mr. Smith's applicant as a "Future Boat Storage Facility."

We respectfully requested that all the recipients of this letter review our attached letter of April 26, 1996 and investigate same.

We are also making known to these authorities by copy hereof, that the city of Sugar Hill, and the abutting property owners on all sides are also vehemently opposed to this commercial enterprise on a residential R-100 zoned property.
