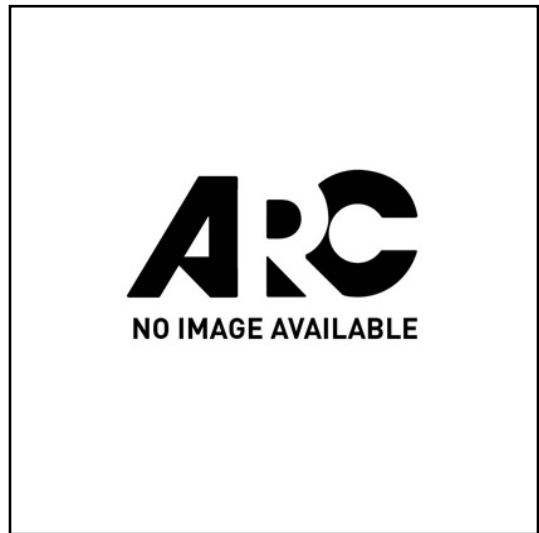

**Detailed Description and Justification**

This concept and master plan supports regional goals to increase access to the river corridor while increasing bicycle and pedestrian use in the region. The master plan encompasses the stretch of river from Buford Dam to Chattahoochee Bend State Park. A Chattahoochee River trail is one of Walk Bike Thrive's "network expansion opportunities" connecting the southwestern part of the region to the Silver Comet Trail, Atlanta Beltline and other significant destinations. Cobb County, City of Atlanta and Trust for Public Land propose the development of the Chattahoochee River 100 Mile Greenway Plan. The project includes master planning and the development of three concept reports and one environmental document.

Phase 1: Along the western side of the River from Mableton Parkway (SR 139) to I-285; (approx. 3.1 miles in length)

Phase 2: Along the eastern side of the River from Donald Lee Hollowell Parkway (US 78) to Marietta Blvd; (approx. 3.9 miles in length)

Phase 3: A bridge connection between Phases 1 and 2 somewhere between Donald Lee Hollowell Parkway and I-285; The project would also include several trailheads, parking lots, and/or trail access point from the adjacent roadways.

The exact number and location of these will be reviewed in the concept phase.
