## Detailed Description and Justification

Section 5310 funds provide assistance in meeting the transportation needs of elderly and disabled persons where public transportation services are unavailable, insufficient or inappropriate. The program ensures that the planning and design of facilities and services are accessible and effective for these groups, and it guarantees that all federal programs offering assistance to public transportation contain provisions to implement these policies. The program requires coordination with other federally assisted programs and services in order to make the most efficient use of Federal resources. Funding is allocated to the State by a formula based on the number of elderly persons and persons with disabilities according to the latest available census data. For a breakdown of how these funds are used in the region, refer to the Transit Program Appendix of the TIP. This line item covers the apportionment for the Atlanta Urbanized Area.
