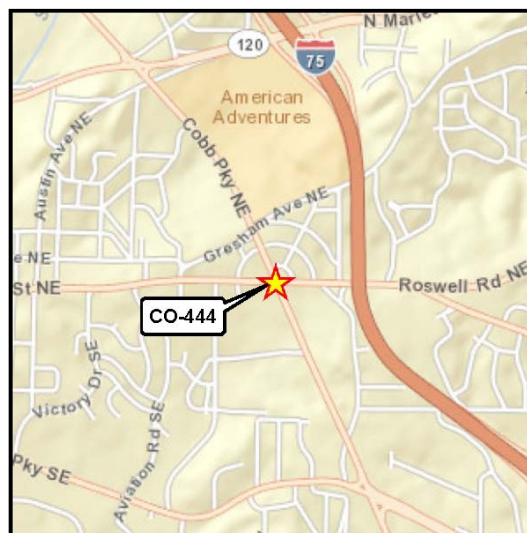

Detailed Description and Justification

This project includes intersection improvements on the eastern side of the intersection which improves pedestrian safety, access to transit and vehicular movement safety improvements. This project would complement the intersection improvements that will be constructed as part of the project along Roswell Street between Dodd Street and US 41 which was constructed as part of the 2005 SPLOST. There is currently matching funds available in the 2011 SPLOST. The project was identified in the 2011 SPLOST and the City of Marietta Transportation Improvement Plan based on the frequency of accidents (in which the top ten intersections were prioritized). It will also be included in an update to the County Transportation Plan which was recently initiated. The project is being funded under the Roadway Operations and Safety Program, a regional program defined in PLAN 2040 to make smaller-scale improvements along existing roadways which are the most critical for cross-jurisdictional travel. With the exception of certain systemwide programs with broad benefits across a defined geographic area, eligibility under this program is limited to facilities on the Regional Strategic Transportation System, with additional priority given to those also identified as a Regional Thoroughfare. US 41 is designated as Level 2 Regional Thoroughfares in the immediate vicinity of this intersection, while SR 120 is a facility on the RSTS.
