## Lifelong Mobility and Accessibility




# 75% of all respondents felt mobility and accessibility are important community attributes



#### Lifelong mobility and accessibility provide access and transportation, including walking, to people of all ages and abilities

Lifelong communities provide ways for people to travel safely and conveniently. Mobility and accessibility means that it is easy and safe for you to get around your community regardless of age or ability. - **A**. Adequate transportation options for non-drivers

- G Curb cuts at all intersections
- H. Sidewalks free of clutter in pedestrian spaces

- J. Pedestrian friendly sidewalk paving

- K. Sidewalk access maintained during local construction
- L. Trees for shade
- M. Plantings and fencing positioned to reduce traffic
- N. Engaging building frontages that welcome pedestrians
- O. Accommodation for use of power wheelchairs, etc
- P Plentiful seating accommodations in welcoming spaces
- Q. Areas of sun and shade considered in the street design
- R. Transit stops with protected seating from harsh weather
- S. Adequate location of accessible transit stops
- T. Traffic calming measures to slow traffic where appropriate



### **Diversity in Housing**




# 60% of all respondents felt that diversity in housing choices are important community characteristics



#### Lifelong communities offer multiple housing options at various price points to allow people to remain in their communities as their needs change

Lifelong Communities feature homes that range from low to high mortgage and rent costs. That allows people to move into larger or smaller homes depending on their needs without having to move out of their communities. "Visitable housing" means that homes provide access to people in wheelchairs and walkers: this includes having at least one stepless entry, wide halls and doorways, and a full or half bath on the main floor. 


# 74% of all respondents identified opportunities for social interaction as important community characteristics

## **Opportunities for Healthy Living**




#### 65.1% of all respondents felt that opportunities for healthy living are important community attributes

### **Access to Services**




79% of all respondents identified access to services as an important community attribute
