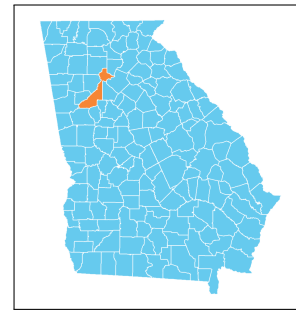


Fulton County, Georgia Early Childhood Profile

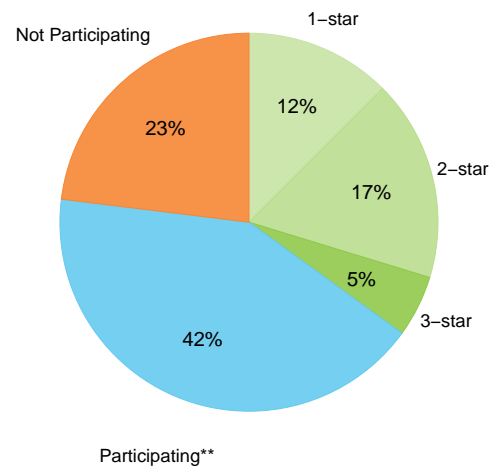

Of every 20 children ages 0-5 in Fulton County, Georgia, **8 are economically disadvantaged, including 5 living in poverty.**⁶
