

Description, Purpose and Benefits This project will relieve congestion, improve safety and provide multimodal transportation options along the heavily traveled Mt. Vernon Road commuter corridor. Most of the Mount Vernon corridor, which is a major east/west connection between the Peachtree Corners area of Gwinnett County and the Central Perimeter business center, currently consists of two lanes that carry over 19,000 vehicles per day. Several signalized intersections lack basic operational improvements such as left turn lanes. Sidewalks are present on only one side of the street despite bus service along the corridor. The Mount Vernon Road corridor improvement project includes center turn lanes, bike lanes and sidewalks between Ashford Dunwoody Road and Mount Vernon Place. Intersection improvements will occur at Vermack Road and Tilly Mill Road. The proposed project can be constructed within the existing right of way over most of the corridor. Where additional right of way is needed (mostly at intersections) very few parcels will be involved. The project is identified in City of Dunwoody's recently adopted transportation plan. Mt. Vernon Road is on the Regional Strategic Transportation Sytem. The total amount of TIA funding committed to advance the scope of this project is \$12,000,000.
