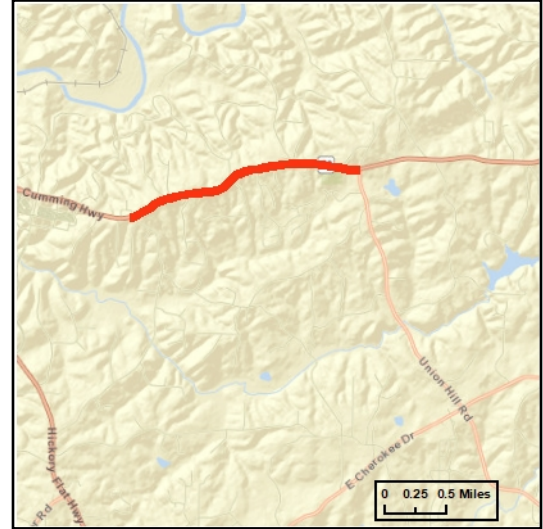

Detailed Description and Justification

This project widens this critical East-West Corridor linking Canton to Forsyth County and Cumming from 2 to 4 lanes. GDOT is sponsoring the preparation of an Environmental Impact Statement (EIS) to identify potential improvements to the State Route 20 corridor between the cities of Canton and Cumming. The SR 20 Improvements study area extends for approximately 24 miles, between I-575 in Canton and SR 400 in Cumming. Jurisdictions along the corridor including the City of Canton, unincorporated communities of Buffington, Macedonia, Ironge, and Free Home in Cherokee County, as well as the unincorporated community of Ducktown and the City of Cumming in Forsyth County. The SR 20 Improvements project will conduct engineering and environmental studies to evaluate possible alternatives to relieve congestion, improve mobility, and reduce crashes along SR 20 between Canton and Cumming.
